

## Parent and Student Consent Agreement

The undersigned student and parent(s) hereby consent to the participation or no participation in the **Thomas Jefferson High School Music Trip to Orlando, Florida from April 1 – April 7, 2019.**

We understand that the chaperones are volunteering their time to assist the directors in monitoring the students during the trip and that the directors, school administrators, and chaperones cannot assume any responsibility for the behavior of individual students. All rules and regulations outlined in the Thomas Jefferson High School Handbook will be strictly enforced.

We hereby waive any claims against, and release, and forever discharge any liabilities of any and all directors, school administrators, and chaperones for any damage or injury to the student or his or her property, which may occur during the trip, except for willful misconduct or recklessness.

We also understand that our personal policies for liability and medical insurance shall be the primary coverage.

We certify that the student has no known medical problems or allergies, is not taking any medications, and has not been recently exposed to any communicable diseases except as described on the Student Medical Information Form. We understand that if a medical problem or condition arises, every reasonable attempt will be made to contact the parent(s) or other responsible adults designated.

We understand that if the medical condition requires that the student be returned home, the parent(s) or the responsible adult designated will be contacted, if possible, prior to sending the student home. We agree that the determination to send the student home due to a medical condition will be made by a director, one or more staff members, and a physician.

We, the parent(s), acknowledge our responsibility for any problem created by the student during the trip, including any disciplinary or other non-medical problem. In the event that one or more staff members and at least one director or school administrator determine that a serious disciplinary or other non-medical problem exists, we consent to their decision to send the student home by the quickest available means **at the parent's expense.**

We further understand that if any Federal, State, or local authorities for any violation or alleged violation should take the student into custody, it shall become the responsibility and obligation of the parent(s) to secure the student's release. We strongly discourage body piercing or permanent tattooing on the trip. Cellular telephones and pagers are permitted and encouraged on the trip but will not be in use during our performances or performances that we may be attending.

If the student must be sent home for any of the above reasons, we, the parent(s) agree to pay for the airline tickets, and/or other special transportation costs, or to reimburse others for any such costs incurred on behalf of the student.

In the event of a medical emergency, we, the parent(s), acknowledge our financial responsibility for reimbursement to the Thomas Jefferson Band Patrons, Inc. for any expenses that may be incurred to provide care for the student.

If any emergency or problem of any kind arises concerning the student, every attempt will be made to reach the parent(s) or named responsible adult at the telephone number designated. If it is impossible to reach any parent(s), or responsible adult, we hereby consent and give authority to one or more chaperones plus one or more directors and school administrator to take such action as is reasonably necessary under the circumstances and we, do hereby release forever discharge any and all chaperones, school administrators, and directors from any claims, liability, or causes of action whatsoever regarding any damages, suits, injury, demands whatsoever in law or in equity to the student or his or her property resulting from their acts or actions, except for willful misconduct or recklessness.

We, parent(s) and student, pledge that during the entire trip there will be no purchases, transportation, or use of any tobacco products, intoxicating beverages, drugs, or other hazardous, abusive, or illegal substances or other illegal articles of property.

**This is not a mandatory band trip. Participation does not affect your grade.**

**Please make a copy of this agreement for your records and return all three original pages to the treasurer no later than September 22, 2018. All forms are required to be returned even if you are not participating in the trip.**

As of September 6, 2018, the **approximate** cost of the trip is \$1,760.00 assuming four students per room.

The **final cost per student and Payment dates are subject to change as a result of an adjustment in any or all of the following:**

- 2) Final Itinerary**
- 3) Increase in Fuel Charges**

Payment schedule is as follows:

- 1) A non-refundable deposit of \$250.00 is due September 30, 2018.**
- 2) Payment two: \$500.00 due October 31, 2018**
- 3) Payment three: \$500.00 due November 30, 2018**
- 4) Payment four: \$500.00 due January 31, 2019 (Final amount to be determined)**
